



## Textile & Leather Products Recall Notifications-2022 report 02

EU, USA, Canada and Australia have established rapid alert systems to facilitate the rapid exchange of information and measures taken to prevent or restrict the marketing or use of products posing a serious risk to the health and safety of consumers. CTT Textile and Leather Recall Notification Alert No. 2 of 2022 summarizes the first quarter notification information related to textile and leather products. The USA, EU, Canada and Australia reported a total of 53 cases during the period.

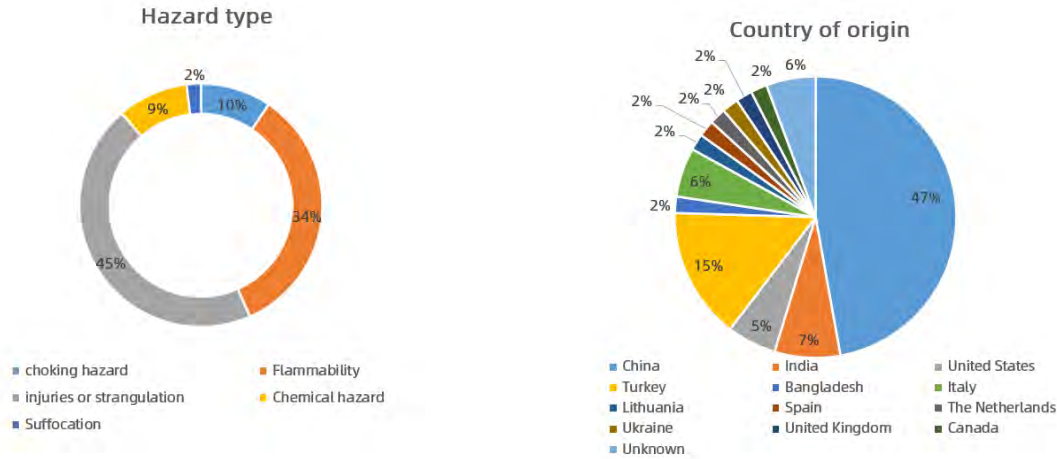

## Textile & Leather Products Recall Notifications-2022 report 02



Among the recall cases in this quarter, the proportion of recalls caused by injuries or strangulation was as high as 45%, flammability accounted for 34%, chemical hazard accounted for 9%, choking hazard accounted for 10%, and Suffocation accounted for 2%. The chemical hazards mainly come from the excessive content of phthalates and Chromium (VI). Among the countries of origin of all recalled products, there were 25 products from China, accounting for 47% of the total number of recalls, ranking first.

### Some typical cases are as follows:



Product :	Children's sports outfit
Country of origin:	China
Alert submitted by:	Romania
Risk type:	The products bear cords with free ends and toggles in the hood area. These drawstrings can become trapped during various activities of a child, leading to injuries or strangulation.
Measures ordered:	Withdrawal of the product from the market (By: Distributor ).



Product :	Children's pajamas
Country of origin:	China
Alert submitted by:	USA
Risk type:	The children's pajamas fail to meet the tight-fitting flammability standards for children's sleepwear, posing a risk of burn injuries to children.
Measures ordered:	Consumers should immediately take the recalled sleepwear away from children and contact Loulou Lollipop for a full refund.



## Textile & Leather Products Recall Notifications-2022 report 02



Product :	Children's shoes
Country of origin:	China
Alert submitted by:	Italy
Risk type:	The plastic material of the product contains an excessive amount of bis(2-ethylhexyl) phthalate (DEHP) (measured values up to 7.3 % by weight). This phthalate may harm the health of children, causing possible damage to their reproductive system.
Measures ordered:	Import rejected at border .



Product :	Baby Boy Rompers
Country of origin:	India
Alert submitted by:	USA
Risk type:	The metal snaps on the rompers can detach, posing a choking hazard to young children.
Measures ordered:	Consumers should immediately take the recalled rompers away from children and return the rompers to any The Children's Place store for a full refund.



Product :	Children's Sleep Bag
Country of origin:	China
Alert submitted by:	Norway
Risk type:	The neck opening of the footmuff is too large in relation to the child height/age. This can increase the risk of the baby to slip inside the sleep bag which could cover mouth and nose and cause suffocation.
Measures ordered:	Recall of the product from end users (By: Importer ).

Different markets have different requirements for textiles and leather footwear products. Therefore, it is particularly important to understand the requirements of export markets for products, especially for children's products, and to design and produce in strict accordance with relevant regulations and standards. Avoid the risk of recalls or claims due to product quality issues.

为了保障消费者的合法权益，欧盟、美国、加拿大和澳大利亚等国家建立了专门的预警通报机制，对不合格纺织和皮革类产品进行通报。CTT纺织和皮革类召回通报预警2022年第2期汇总了第二季度有关的纺织和皮革类产品的通报信息。在该期间，欧盟、美国、加拿大和澳大利亚通报案例共53例。

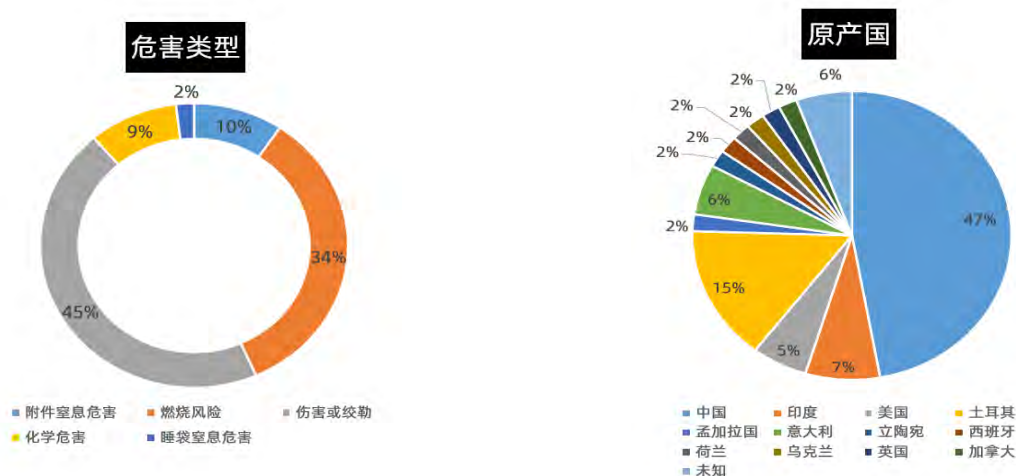

## 纺织和皮革类产品召回通报预警—2022年第2期



本季度召回案例中，伤害或绞勒产生的召回比例高达45%；燃烧风险占34%；化学危害占9%，主要包括邻苯二甲酸盐、六价铬超标；附件窒息危害占10%；睡袋窒息危害占2%。所有被召回产品的原产国中，来自中国的产品共25例，占召回总数的47%，位列第一。

### 部分典型案例如下：



产品： 儿童运动套装  
 原产国： 中国  
 通告国： 罗马尼亚  
 风险描述： 产品的功能性绳带较长，在颈部区域有自由端。在儿童的各种活动中，这些绳子可能会被卡住，导致受伤或绞勒。  
 采取措施： 由经销商将产品从市场上撤回。



产品： 儿童睡衣  
 原产国： 中国  
 通告国： 美国  
 风险描述： 儿童睡衣不符合紧身儿童睡衣易燃性标准，对儿童构成烧伤风险。  
 采取措施： 消费者应该立即从儿童手中收回召回的睡衣，并联系Loulou棒棒糖获得全额退款。

## 纺织和皮革类产品召回通报预警—2022年第2期



产品:	儿童鞋子
原产国:	中国
通告国:	意大利
风险描述:	该产品的塑料材料含有过量的邻苯二甲酸酯DEHP。这种邻苯二甲酸酯可能会损害儿童的健康，对他们的生殖系统造成可能的损害。
采取措施:	边境拒绝进口。



产品:	婴幼儿连体衣
原产国:	印度
通告国:	美国
风险描述:	连体衣上的金属扣可能会脱落，造成幼儿窒息的危险。
采取措施:	消费者应该立即将召回的连体衣从儿童手中拿走，并将其退回到儿童商店以获得全额退款。



产品:	儿童睡袋
原产国:	中国
通告国:	挪威
风险描述:	相对于孩子的身高/年龄而言，脚套的颈口太大了。这可能会增加婴儿滑进睡袋的风险，因为睡袋可能会盖住嘴巴和鼻子，导致窒息。
采取措施:	由进口商从最终用户处召回产品。

各个市场对于纺织品及皮革鞋类产品的要求不尽相同，因此，了解出口市场对产品的要求，尤其是儿童产品的要求，并严格按照相关法规和标准进行设计和生产则显得尤为重要，避免因产品质量问题而导致召回或产生索赔的风险。
